Tulip River Cruises 2021 Travel Reservation Terms & Conditions

Deposit-Cancellation Fees:

The hotels, buses and vendors that we use for the Tulip River Cruise require that we pay a non-refundable deposit for every passenger that we book. We will be paying them approximately \$1,500 per person within 30 days of your initial deposit. We know you have only paid us a \$500 deposit. This is not a problem, we will advance the rest. We know that you are serious and really plan to go, so this is not a great risk on our part. History has shown us that very few of our passengers ever cancel. However, please carefully read through this policy carefully so that you are aware of the cancellation deadlines and penalties.

Here is our Cancellation Policy for our special Tulip River Cruises 2021 Cruises:

- **Cancelling after your initial deposit up to 1 year prior to departure date:** the initial deposit of \$500 is nonrefundable, but it can be transferred to another trip offered by Fun For Less Tours within 2 years of cancelling. All other monies will be returned.
- **Cancelling from 1 year to 6 months prior to departure date:** 50% per person of your total invoice is non-refundable and non-transferable.
- **Cancelling inside of 6 months prior to departure date:** 100% of your total invoice is nonrefundable and nontransferable.
- The above cancellation policy may change and become a higher non-refundable or non-transferable amount if Fun For Less Tours has purchased non-refundable airline tickets or other non-refundable items for the passengers.
- Major Exception: **With the huge response we have had to our 2021 Tulip River Cruises, we expect that we will sell out completely. Those requesting the tours after our inventory is sold-out will be put on a wait list. If, for some reason, someone needs to cancel inside of a year prior to their departure date and we have others from our wait list who are willing to take their place, we will take the money from the wait list passengers and give it to those that are cancelling – minus any change fees. It is also at the discretion of the River Cruise Line. Once we are within 120 days of sailing name changes are not allowed.**
 - **CHANGE POLICY:** Change requests will be considered on a case-by-case basis. Adding passengers to your reservation is not necessarily considered a "change". Changes in names of passengers already booked, and changes to room or cabin reservations will be assessed a fee. Any changes to airlines, river cruise, etc. will be assessed the change fees charged by the airlines, river cruise etc. Changes are subject to approval by the airlines and river cruise, etc. Change requests must be made over the phone with one of our agents and will be done only after river cruise or airline approval.

Important Note: Airlines may change, cancel or discontinue flights at their discretion. Fun For Less Tours is not responsible for any costs associated with such changes.

IMPORTANT TRIP PROTECTION INFORMATION:

We **strongly** recommend the purchase of a Trip Protection policy through Travelex, which can cover trip delays, cancellations or interruptions due to unforeseen reasons. It is important for you to understand that starting more than 1 year in advance, your money has been paid to our vendors and we no longer have it for reimbursement. Please refer to our cancellation policy on the previous page. The only way to protect your trip is through Trip Protection.

Fun For Less Tours is not responsible for policy provisions or coverage, as this is the sole responsibility of the Trip Protection company. It is your responsibility to verify and understand your coverage. Fun For Less Tours is not responsible nor liable for personal injury, accident and/or illness, or for loss, theft, or damage of luggage and/or personal items. For your own protection, it is wise to purchase Trip Protection to cover these unusual circumstances.

We recommend the Travel Select policy. If you purchase the Trip Protection within 21 days of booking your trip, you may receive the added benefit of the Pre-Existing Medical condition waiver. You may also purchase the Business Upgrade within 20 days if there is a possibility you may have to cancel due to work responsibilities.

Should cancellation occur, Travel Consultant liability is limited to the monies received by Travel Consultant subject to our stated Cancellation Policy and is not responsible or liable for defaults of those not directly under our control. Travel Consultant assumes no responsibility and cannot be held liable for any wrongful, negligent or unauthorized acts or omissions of any travel consultant, agency or tour operator other than our own.
